**Functions of State Level Steering Committee (SLSC):**

The State Level Steering Committee (SLSC) shall monitor and over see the following:

1. Preparation of Strategic/Perspective and annual State Level Action Plan in consonance with Mission’s goals and objectives and in close co-ordination with Technical Support Group, State Agriculture Universities (SAUs) and Indian Council of Agriculture Research (ICAR) institutes.
2. Approval of the proposals of state level organizations/agencies under NBHM.
3. Selection of Member society/Firms/Companies & registered entities of NBB for implementation of NBHM activities.
4. Monitor receipt of funds from National Bee Board, for carrying on Mission’s activities, maintain proper accounts thereof and submit utilization certificate to concerned agencies;
5. Monitor the progress of formation of Farmers and Producers Organization (FPOs) to achieve economies of scale and scope and mobilize credit requirement of farmers through Financial Institutions.
6. Monitor release of funds to implementing organizations.
7. Oversee implementation, monitoring and supervision of schematic activities in the states through farmers, societies, grower associations, self-help groups, state institutions and other similar entities;
8. Ensure organisation of workshops, seminars and training programmes for all interest groups/associations at state level, with the help of SAUs, ICAR Institutes, Krishi Vigyan Kendras (KVKs) and other institutions having technical expertise;

**Functions of District Level Committee (DLC)**

1. Approval of the District Annual Action Plan of the proposals of state level organizations/agencies under NBHM based on the requirements and specific needs of the Districts.
2. Examination & Recommendation of the proposals relating to setting up of infrastructural facilities under NBHM of the member societies/Firms/companies & registered entities of National Bee board
3. Ensure co ordination between line Departments.
4. Approval of identified farmers list under NBHM scheme.
5. DLC shall over see and monitor the progress and implementation of NBHM scheme.
6. Ensure the organisation of trainings, Seminars and exposure visits to the identified farmers under the scheme.
7. Monitor submission of Monthly Progress reports to NBHM headquarters.
8. Financial approval for release of assistance to the beneficiaries who have implemented the NBHM scheme.

2. The District Level Committee (DLC) will be responsible for carrying forward the objectives of the Mission for project formulation, implementation and monitoring and ensure smooth functional linkages among different agencies and meet as frequently as possible as required.

3. The Director of Horticulture, Hyderabad shall take necessary action accordingly.
