**ORDER:**

The Telangana Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 2018 issued by the Government of India vide GSR 820(E) dated 29-8-2018 was re-published in the G.O. first read above and has come into force on 29-8-2018. According to para 3 (1) of the said Order, the State Government shall within a period of thirty six months from the commencement of the Order, organize classes of posts in the Civil Services and classes of Civil posts under the State into different local cadres for different parts of the State to the extent and in the manner specified therein.

2. The Scheme for organization of local cadres in Horticulture Department in accordance with the provisions under para 3 of the Telangana Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 2018 has been carefully considered and approved by the Government. The scheme as approved by the Government is appended to this order.

3. The unit of appointment for the posts organized as district, zonal and multi-zonal cadres, including the posts that may be sanctioned in future, shall be the district, zone and multi-zone, respectively. The appointing authority in respect of each of these units shall be as specified in the relevant Service Rules. The extent of preference in favour of local candidates in the matter of direct recruitment shall be as laid down in the Telangana Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 2018.

4. The Principal Secretary to Government, Agriculture & Co-Operation Department and the Director of Horticulture are requested to strictly follow the scheme as approved in this order and the provisions of the Telangana Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 2018. They are also requested to fix the cadre strength of the respective local cadres as per the sanction of posts accorded by the Finance Department and take necessary action to amend the Service Rules, wherever necessary, in the light of the organization of local cadres approved in this order.
