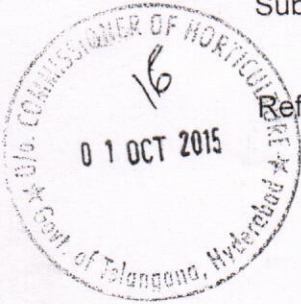

The attention of the Commissioner of Horticulture, Telangana State, Hyderabad is invited to the references cited. The Commissioner of Horticulture in his letters 3rd to 5th cited has recommended certain modifications to G.O. 1st and Govt. Memo. 2nd cited. In the circumstances stated by the Commissioner of Horticulture, Government after careful examination of the matter, issue the following modifications to the G.O.Ms.No. 30, A & C (Horti & Seri) Department, dated. 18.12.2014 and Govt. Memo. No.3071, A & C (Horti & Seri) Department, dated:08-06-2015 as follows:

- A) Direct payment of subsidy amount to farmers who are willing to take up the installations on their own.
- B) In case of direct payment to farmer, the farmer shall be responsible for the completion of the installation work on time, duly following the technical specifications mentioned as per the G.O.Ms.Nos.30, Dt:18.12.2014, of A&C (Horti.& Seri) Dept. and any deviations observed shall draw penalty on the subsidy amount to the extent of deviations that shall be recommended after 3rd party inspection.
- C) To involve more number of players under the programme, Registration of polyhouse companies shall be taken up by the Department in addition to earlier Empanelled companies. In this case, a minimum security deposit of Rs.2.00 lakhs may be collected from registered company instead of Performance Bank Guarantee. The offered rates by them shall be negotiated at Commissioner level.
- D) Both the implementation procedures 1) direct payment of subsidy to farmer & 2) through empanelled companies shall be adopted as per the choice of the farmer.
- E) For release of subsidy in both the cases i.e., (D) the MIDH rates shall be taken as bench mark. The mode of payment to farmers and empanelled companies shall be in following 3 stages as per the minutes approved on 23.06.2015.
1. I stage – 35% payment after foundation and delivery of material
 2. II stage – 50% payment after installation and inspection.
 3. III stage – 15% payment after 3rd party verification

The Commissioner of Horticulture is requested to take necessary action accordingly.


