ORDER:

In the circumstances reported by the Director of Horticulture, Hyderabad, in the reference 6th read above, Government after careful examination hereby issue the following addition to the existing Telangana State Micro Irrigation Project (TSMIP) guidelines issued in the references 1st to 5th read above as follows:

Addition to Para 5 (III) :

- (a) The Farmer Beneficiaries who have already availed the benefit of Micro Irrigation who are currently barred from availing further assistance for the same land for the next (7) years, can now avail assistance for Micro Irrigation for Oil Palm Crop within the 7 years period for the same land/same survey numbers.
 - (b) The maximum permitted area that is restricted up to a farm size of 5 Ha / 12.5 acres per each family to all crops, can now avail assistance for Micro Irrigation for Oil Palm up to 12.5 acres (5 Ha.) / planting area per each family including those who have availed Micro irrigation for other crops previously.
 - (c) The Extension of scheme to the beneficiaries who have already availed the scheme earlier for other crops for complete 12.5 acres / 5 Ha, shall be permitted to take up the Oil palm crop up to 12.5 Acres / 5 Ha area in one contiguous area or at different locations.
 - (d) The oil palm Farmers should be considered for Direct Benefit Transfer (DBT) to Farmer as per their choice at the time of Registration.
2. The Director of Horticulture, Hyderabad shall take necessary action accordingly.
