Sub: Horticulture Department – TSMIP – Modification of subsidy pattern under Drip Irrigation for Small / Marginal farmers and Backward classes farmers – Certain Modifications Issued.

Ref: 1. G.O.Ms.No. 28, A & C (Horti & Seri) Department, dated. 9.12.2014.
2. From the Commissioner of Horticulture, Telangana, Hyderabad, Lr.No.TSMIP/P&M/41/2014, Dated. 20.12.2014 & 2.1.2015.

The attention of the Commissioner of Horticulture, Telangana, Hyderabad is invited to the reference cited. The Commissioner of Horticulture in his letter 2nd cited, has recommended certain modifications to G.O. 1st cited. In the circumstances stated by the Commissioner of Horticulture, Government after careful examination of the matter, issue the following modifications to the G.O.Ms.No. 28, A & C (Horti & Seri) Department, dated. 9.12.2014 as follows:

1. Para 5 – I is substituted as follows:

I. "All category farmers in revenue village irrespective of their economic status are eligible for Drip Irrigation/Micro Irrigation systems up to 5 ha or land holding possessed by the farmers in Title Deed, whichever is less, with the following subsidy pattern:

- All SC/ST Farmer are eligible for 100% subsidy.
- All BC farmers are eligible for 90% subsidy.
- All other caste farmers are eligible for 80% subsidy.
- Portable Sprinklers for all category farmers are eligible for 75% subsidy limited to 1 ha. unit only.

2. Para 5 – II (b) substituted as follows :-

(b) Definition of Beneficiary Farmer categories:

- i. Farmers with holding upto 2.5 acres of dry land or 1.5 acres of wet land are defined as Marginal Farmers.
- ii. Farmers with holding upto 5 acres of dry land or upto 2.5 acres of wet land are defined as Small Farmers.
- iii. Farmers with land holding above 5 acres of dry land or above 2.5 acres of wet land are defined as Other Farmers.

3. Para 5 - III modified as follows :-

The Farmer Beneficiaries who have already availed the benefit of Micro Irrigation cannot avail further assistance for the same land, for the next 5 years.

4. Para 5 – IV substituted as follows:-

IV. In the selection of Beneficiaries, not less than

- a. 16.05% of the total financial target shall be covered by Scheduled Caste farmers.
- b. 9.55% of the total financial target shall be covered by Scheduled Tribes farmers.
- c. Not less than 25% of total financial target shall be covered by BC farmers.
- d. Not less than 50% of the total financial target shall be covered SF/MF farmers.
- e. Not exceeding 10% of financial target shall be covered by other farmers (more than 5 acres land holding)

5. Para 5 – VI (d) is modified as follows:-

- (d) Preference may be given to Small and Marginal Farmers, SC/ST/BC/Women and differentially abled (PH) farmers.

6. Para 5 – VI (e) is modified as follows:-

- (e) It should be ensured that, as per the directives of SC, ST Act 16.05% and 9.55% funds are to be targeted for SC & ST farmers respectively under SC Sub-Plan and Tribal Sub-Plan and at least 25% funds for Backward Class farmers.

7. After para 5 (VI), the following para is inserted as follows:

- VII.** Further to supply one Drip lateral roller for each drip beneficiary farmer on subsidy basis i.e., (SC / ST – 100%, BC farmers– 90% & Other caste farmer 80%) by including cost of drip lateral roller @ cost of Rs.1500/- by including in unit cost of all drip crops and budget for year 2014-15.

The Commissioner of Horticulture, Hyderabad shall take necessary action accordingly.
